Rev. Jim Monnett moved to adjourn to so that a quorum could be established. Motion carried by unanimous consent.

# Presbytery of Detroit Minutes of the Adjourned Meeting July 13, 2021

The Presbytery of Detroit convened with prayer and a land acknowledgment in an adjourned meeting at Jefferson Avenue Presbyterian Church in Detroit.

The Moderator declared the presence of a quorum.

**Worship:** The assembly celebrated worship with communion. Isaac Delezenne, Rev. Garrett Mostowski, Rev. Kevin Johnson, and Elder Charon Barconey led worship. Rev. Sarah Logemann preached on Matthew 13:31-35, challenging the Presbytery to allow God to "Rise Up!" the Presbytery, in Christ and with one another, and remember that God is at work within our midst, in a sermon entitled "The Little Red Hen and the Kindom of God." Rev. Opelton Parker's Jazz Ensemble offered special music.

The Moderator appointed Rev. Judi McMillan Assistant to the Stated Clerk.

The Moderator welcomed all new ministers and commissioners.

Rev. Matthew Nickel welcomed the Presbytery on behalf of the

<u>Upon motion</u> of Rev. Neeta Nichols, Presbytery approved the following as Omnibus #1:

Excuse all continuing minister and elder members of Presbytery who have asked to be excused.

Seat as corresponding members all eligible persons who are presented to the Presbytery and who register as corresponding members: Rev. Chip Hardwick, \_\_\_\_\_ Presbytery.

<u>Upon motion</u> of Elder Kevin Smith, Presbytery approved the docket with the times amended to add forty minutes to each time.

**Report from Rev. Chip Hardwick, Synod of the Covenant:** Rev. Hardwick reported on behalf of the Synod that the Synod had awarded 54 scholarships for higher education, including several from Detroit Presbytery. Rev. Hardwick also reported that the Synod had offered leadership development workshops from Leaderwise and the Presbytery had taken advantage of this training for boundaries. Additionally, the Synod had offered preaching workshops which were available on the Synod's YouTube channel.

**Transitional General Presbyter's Report:** Rev. Floretta Barbee-Watkins celebrated ordination anniversaries. Rev. Barbee-Watkins reported that the Presbytery was hard at work looking at its structure and bylaws. Rev. Barbee-Watkins reported that the Committee on Nominations needed additional nominees and those willing to serve. Rev. Barbee-Watkins also shared the "Zoom at Noon" as a time for leaders to share thoughts and ideas.

Associate Executive Presbyter's Report: CRE Charon Barconey reported that the past fifteen months had not been easy for church leaders and members. CRE Barconey shared a parable: that she had learned that hairdressers turn clients away from the mirror, because sometimes the process of transformation is messy. In the same way, the Presbytery was undergoing transformation, and CRE Barconey called the Presbytery to trust God through this process. CRE Barconey shared good news that the Presbytery was moving forward with the Vital Congregations Initiative through a number of congregations. The Presbytery's start date was January 2022, so additional congregations could sign on.

The assembly recessed for dinner. Rev. Kara Hildebrandt offered a blessing, and recognized the birthday of Elder Jean Moore.

The Moderator offered a prayer for openness.

<u>Upon motion</u> of Rev. Jim Monnett, Presbytery postponed the recognition of staff transitions to the September meeting.

**Treasurer's Report:** Treasurer Mike Gaubatz presented the report. The Treasurer reported that the Presbytery revenues were slightly above expected and expenses slightly below expected due to staff changes.

**Trustees' Report:** Rev. Kara Hildebrandt reported on behalf of the Trustees. **Appendix A**. <u>Upon motion</u> of Trustees, Presbytery approved the sale of the property of the former Peace Presbyterian Church, now held by New Life Presbyterian Church, and legally described as:

to Poblo International, a nonprofit Christian Mission, for \$395,000.

**Report of the Committee on Nominations:** Elder Rosy Latimore reported on behalf of the committee that CRE Charon Barconey would receive nominations on behalf of the committee, and that her desire was that every congregation be represented in the Presbytery committees, teams, and workgroups.

<u>Upon motion</u> of Rev. Ruthanne Herrington, and after debate, Presbytery elected Ruling Elder Gregory Biery to serve on the Committee on Ministry for the class of 2022.

Elder Rosy Latimore continued the report, relaying that the 2022 General Assembly would take

place in a hybrid process, with its meeting July 5-9, committee meeting beforehand. The Presbytery would be taking applications for commissioners to General Assembly.

**Coordinating Cabinet:** Rev. Julie Delezenne reported for the Coordinating Cabinet. **Appendix B.** Rev. Delezenne's report included the following reports.

Mission Interpretation Ministry Team: Rev. Adam Delezenne and CRE Ruth Azar reported on behalf of the Second Mile Center. CRE Azar reported that the Second Mile Center had purchased its building from the Presbytery and had held Vacation Bible School, health fairs, and education in American Sign Language, among many other ministries. CRE Azar also reported that the Center had put together meals for children during COVID stay-at-home orders and brought them to children's homes. CRE Azar called for the Presbytery to pray for the Second Mile Center.

**New Church Development:** Rev. Judi McMillan reported that the Holy Sprockets was a new worshiping community for cyclists, part of 1001 New Worshiping Communities.

**Planning and Visioning:** Elder Kevin Smith reported that Planning and Visioning was working on reviewing the data received from NorthStar Strategies, in consultation with the Bylaws Committee, and that a team would be created for this review.

Bylaw Amendments: Rev. Delezenne continued the report.

<u>Upon motion</u> of Cabinet, Presbytery appointed a Special Committee to Review the Bylaws consisting of the following persons: RE Suzanne Lewand (Royal Oak, First); TE Garrett Mostowski; TE Thomas Oxtoby, Chair; RE Autumn Palmer (Detroit, Westminster); RE Rhonda Favors Smith (Detroit, Calvary); and the following ex oficio members, with voice but not vote, not to be included in the quorum: the Stated Clerk; the Transitional General Presbyter; the Associate Executive Presbyter; the Chair of the Coordinating Cabinet; the Moderator of the Presbytery; and the Vice-Moderator of the Presbytery.

The Bylaws Committee shall develop a new set of Bylaws to help the Presbytery live out its new understanding of its identity, purpose, vision, and mission. In developing new Bylaws, the Bylaws Committee shall work closely with the Planning and Visioning Team and the Coordinating Cabinet to interpret and implement the results of the North Star Strategies planning process. The Bylaws Committee shall give particular attention to dismantling any structural racism that may be built into the current Bylaws. The Bylaws Committee shall encourage communication from all of the Presbytery's stakeholders.

The Bylaws Committee shall submit its recommendations to the Coordinating Cabinet. In accordance with the current Bylaws, the Coordinating Cabinet shall propose to the Presbytery any amendments to the Bylaws. The quorum of the Committee shall be the majority of its members.

<u>Upon motion</u> of Coordinating Cabinet, and following notice published ten days prior on the Presbytery's website, the Presbytery amended the Bylaws as follows: Add the following words at the end of Article III, section 5: "The Presbytery, and any of the committees or other entities that report to it, may meet by electronic means, or may permit participation by electronic means at an

otherwise in-person meeting, if notice in writing is posted not less than ten days in advance of the meeting, so long as all members shall have the ability to discuss and vote on all business items, as per the standing rules for electronic meetings voted on by the Presbytery."

Motion carried, 68-0.

<u>Upon motion</u> of Coordinating Cabinet, and following notice published ten days prior on the Presbytery's website, the Presbytery amended the Bylaws as follows: Strike out the first three sentences of Article III section 4 and insert the following in their place: "Special meetings may be called by the Coordinating Cabinet. The Moderator may also call a special meeting with the concurrence of five teaching elders and five ruling elders, the ruling elders being from five different churches. If the Moderator is unable to act or declines to act, the Vice-Moderator may call a special meeting with the same concurrence. The Stated Clerk shall call a special meeting upon the request of fifteen teaching elders and fifteen ruling elders, the ruling elders being from fifteen different churches."

The section would then read as follows: "(Meetings: Special Meetings) The Moderator shall call a special meeting at the request, or with the concurrence, of two teaching elders and two ruling elders, the ruling elders being of different churches. Should the Moderator be unable to act, the Vice Moderator shall, under the same conditions, issue the call. If both Moderator and Vice Moderator are unable to act, any three teaching elders and three ruling elders, the ruling elders being of different churches, may call a special meeting. Special meetings may be called by the Coordinating Cabinet. The Moderator may also call a special meeting with the concurrence of five teaching elders and five ruling elders, the ruling elders being from five different churches. If the Moderator is unable to act or declines to act, the Vice-Moderator may call a special meeting with the same concurrence. The Stated Clerk shall call a special meeting upon the request of fifteen teaching elders and fifteen ruling elders, the ruling elders being from fifteen different churches. Notice of a special meeting shall be published in writing not less than ten days in advance to each teaching elder and to the session of every church. The notice shall set out the purpose of the meeting, and no other business than that listed in the notice shall be transacted."

Motion carried, 70-0.

<u>Upon motion</u> of Coordinating Cabinet, and following notice published ten days prior on the Presbytery's website, the Presbytery amended the Bylaws as follows: Add the following words at the end of Article XI, section 5.b.vii: "The Trustees shall have the power to approve, on behalf of the Presbytery, the sale, encumbrance, or purchase of property by a congregation, including the power to review, approve, and execute any necessary contracts for said purpose, subject to the condition that the property description and amount have been approved prior to the transaction, first by the Committee on Ministry, and then by the Presbytery at a duly constituted meeting. In place of a dollar amount, the Committee on Ministry and Presbytery may at their discretion approve a transaction at fair market value, with fair market value to be finally determined by the Trustees."

The section would then read as follows: "(Work of the Presbytery: Trustees: Responsibilities) Making recommendations to Presbytery concerning Presbytery approval of loans and property

transactions involving churches of the Presbytery. The Trustees shall have the power to approve, on behalf of the Presbytery, the sale, encumbrance, or purchase of property by a congregation, including the power to review, approve, and execute any necessary contracts for said purpose, subject to the condition that the property description and amount have been approved prior to the transaction, first by the Committee on Ministry, and then by the Presbytery at a duly constituted meeting. In place of a dollar amount, the Committee on Ministry and Presbytery may at their discretion approve a transaction at fair market value, with fair market value to be finally determined by the Trustees."

Motion carried, 72-1.

<u>Upon motion</u> of Coordinating Cabinet, Presbytery rescinded Presbytery Policy P-24, which reads as follows: "In those cases where the Trustees determine it necessary to act for the benefit of Presbytery before the next stated meeting of Presbytery, the Trustees are authorized to approve actions on behalf of Presbytery. When they do so, they shall report the action in full to the next stated meeting of Presbytery, along with a statement of why they believed it necessary to act on it."

<u>Upon motion</u> of Coordinating Cabinet, Presbytery approved the Saturday, November 20 meeting to be held at 9:00am and by electronic means.

**Committee on Preparation for Ministry ("CPM"):** Rev. Jim Faille reported for the Committee. **Appendix C**. Rev. Faille reported that the Presbytery had six Inquirers, three Candidates, and four in the CRE program, with additional Inquirer applications received. The Committee had received an Inquirer from the Presbytery of the Pines.

On behalf of the Committee, Rev. Faille presented Charles Sadler as a candidate for ordination. Candidate Sadler responded to questions about the theology of creation, his theology of the resurrection, his theology of the Holy Spirit, and the work of homeless ministry.

<u>Upon motion</u> of Rev. Paul Stunkel, Presbytery arrested the examination.

<u>Upon motion</u> of the Committee on Preparation for Ministry, Presbytery approved that the examination would be sustained and that the Presbytery ordain Charles Sadler.

Committee on Ministry: Rev. Melissa DeRosia reported for the Committee. Appendix D.

The Trustees recommend that Presbytery approve the sale of the property of the former Peace Presbyterian Church, now held by New Life Presbyterian Church, and legally described as:

The Trustees support the recommendation of Coordinating Cabinet for the following change to Presbytery bylaws:

Add the following words at the end of Article XI, section 5.b.vii: "The Trustees shall have the power to approve, on behalf of the Presbytery, the sale, encumbrance, or purchase of property by a congregation, including the power to review, approve, and execute any necessary contracts for said purpose, subject to the condition that the property description and amount have been approved prior to the transaction, first by the Committee on Ministry, and then by the Presbytery at a duly constituted meeting. In place of a dollar amount, the Committee on Ministry and Presbytery may at their discretion approve a transaction at fair market value, with fair market value to be finally determined by the Trustees."

The Trustees report the following for the information of Presbytery:

- 1. The Trustees ratified the copier lease as entered into by the Transitional General Presbyter on February 17, 2021.
- 2. The Trustees approved disbursement of the Ranney-Balch funds as approved by Presbytery.
- 3. Trustees authorized transferring the funds from the sale of the property of Covenant-Southfield to be held in the Mission Market investment fund at PILP.
- 4. The Trustees authorized Rhonda Barley, Presbytery bookkeeper, to hold a Presbytery credit card with a limit of \$10.000.
- 5. The Trustees authorized disbursement of \$500 to each of the YMCA and YWCA pursuant to a condition of the McKay fund.

- 6. The Trustees authorized that the combined asset allocation range of equities and REITs in Presbytery investments be changed from 40%-60% to 40%-65% and that the range of allocation of fixed income be changed from 40%-60% to 30%-60%, with Beta not to exceed 1.2.
- 7. Trustees approved \$2000 from the Covenant-Southfield escrow account to pay a consultant for Covenant-Southfield and \$500 for professional expenses from the escrow account. Trustees then approved \$30,600 from the escrow account to enable Covenant-Southfield to continue to operate.

# Presbytery of Detroit Report of the Coordinating Cabinet March 20, 2021

The Coordinating Cabinet recommends that Presbytery:

1. Appoint a Special Committee to Review the Bylaws consisting of the following persons: RE Suzanne Lewand (Royal Oak, First); TE Garrett Mostowski; TE Thomas Oxtoby, Chair; RE Autumn Palmer (Detroit, Westminster); RE Rhonda Favors Smith (Detroit, Calvary); and the following ex oficio members, with voice but not vote, not to be included in the quorum: the Stated Clerk; the Transitional General Presbyter; the Associate Executive Presbyter; the Chair of the Coordinating Cabinet; the Moderator of the Presbytery; and the Vice-Moderator of the Presbytery.

The Bylaws Committee shall develop a new set of Bylaws to help the Presbytery live out its new understanding of its identity, purpose, vision, and mission.

In developing new Bylaws, the Bylaws Committee shall work closely with the Planning and Visioning Team and the Coordinating Cabinet to interpret and implement the results of the North Star Strategies planning process. The Bylaws Committee shall give particular attention to dismantling any structural racism that may be built into the current Bylaws. The Bylaws Committee shall encourage communication from all of the Presbytery's stakeholders.

The Bylaws Committee shall submit its recommendations to the Coordinating Cabinet. In accordance with the current Bylaws, the Coordinating Cabinet shall propose to the Presbytery any amendments to the Bylaws. The quorum of the Committee shall be the majority of its members.

- 2. Amend the Bylaws as follows: Add the following words at the end of Article III, section 5: "The Presbytery, and any of the committees or other entities that report to it, may meet by electronic means, or may permit participation by electronic means at an otherwise in-person meeting, if notice in writing is posted not less than ten days in advance of the meeting, so long as all members shall have the ability to discuss and vote on all business items, as per the standing rules for electronic meetings voted on by the Presbytery."
- 3. Amend the Bylaws as follows: Strike out the first three sentences of Article III section 4 and insert the following in their place: "Special meetings may be called by the Coordinating Cabinet. The Moderator may also call a special meeting with the concurrence of five teaching elders and five ruling elders, the ruling elders being from five different churches. If the Moderator is unable to act or declines to act, the Vice-Moderator may call a special meeting with the same concurrence. The Stated Clerk shall call a special meeting upon the request of fifteen teaching elders and fifteen ruling elders, the ruling elders being from fifteen different churches."

The section would then read as follows: "(Meetings: Special Meetings) The Moderator shall call a special meeting at the request, or with the concurrence, of two teaching elders and two ruling elders, the ruling elders being of different churches. Should the Moderator be unable to act, the Vice Moderator shall, under the same conditions, issue the call. If both Moderator and Vice Moderator are unable to act, any three teaching elders and three ruling elders, the ruling elders being of different churches, may call a special meeting. Special meetings may be called by the Coordinating Cabinet. The Moderator may also call a special meeting with the concurrence of five teaching elders and five ruling elders, the ruling elders being

from five different churches. If the Moderator is unable to act or declines to act, the Vice-Moderator may call a special meeting with the same concurrence. The Stated Clerk shall call a special meeting upon the request of fifteen teaching elders and fifteen ruling elders, the ruling elders being from fifteen different churches. Notice of a special meeting shall be published in writing not less than ten days in advance to each teaching elder and to the session of every church. The notice shall set out the purpose of the meeting, and no other business than that listed in the notice shall be transacted."

4. <u>Amend the Bylaws</u> as follows: Add the following words at the end of Article XI, section 5.b.vii: "The Trustees shall have the power to approve, on behalf of the Presbytery, the sale, encumbrance, or purchase of property by a congregation, including the power to review, approve, and execute any necessary contracts for said purpose, subject to the condition that the property description and amount have been approved prior to the transaction, first by the Committee on Ministry, and then by the Presbytery at a duly constituted meeting. In place of a dollar amount, the Committee on Ministry and Presbytery may at their discretion approve a transaction at fair market value, with fair market value to be finally determined by the Trustees."

The section would then read as follows: "(Work of the Presbytery: Trustees: Responsibilities) Making recommendations to Presbytery concerning Presbytery approval of loans and property transactions involving churches of the Presbytery. The Trustees shall have the power to approve, on behalf of the Presbytery, the sale, encumbrance, or purchase of property by a congregation, including the power to review, approve, and execute any necessary contracts for said purpose, subject to the condition that the property description and amount have been approved prior to the transaction, first by the Committee on Ministry, and then by the Presbytery at a duly constituted meeting. In place of a dollar amount, the Committee on Ministry and Presbytery may at their discretion approve a transaction at fair market value, with fair market value to be finally determined by the Trustees."

- 5. Rescind Presbytery Policy P-24, which reads as follows: "In those cases where the Trustees determine it necessary to act for the benefit of Presbytery before the next stated meeting of Presbytery, the Trustees are authorized to approve actions on behalf of Presbytery. When they do so, they shall report the action in full to the next stated meeting of Presbytery, along with a statement of why they believed it necessary to act on it."
- 6. Hold the Saturday, November 20 meeting at 9:00am and by electronic means.

#### Autobiography of Charles Sadler II

I grew up in the suburbs of Warren and Macomb. When my family moved from Warren to Macomb in 1997 (I was six years old), we found St. Thomas Community Presbyterian Church. That church became a home for us. It was a place where each of us was transformed by God and renewed in the Holy Spirit. As I aged, I felt a call to be more engaged in my church's youth program, so I took on a youth leadership position in service and faith nurturing for three years. I became more serious about my faith. I listened to sermons, I read my Bible, and I felt God's presence in my life. I felt some direction. I felt love and grace from God. I graduated from high school with some confidence in my faith and with feelings of a call. I enjoyed the ministry at my church and felt it was an important part of my life.

I went to Alma College to continue my pursuit of God. To learn more about God, I majored in Religious Studies and Philosophy. Spiritual and religious matters of life were my passion. I explored my relationship with God intellectually. I still had ideas of ministry as an end goal of my education; I had no idea what ministry was. I applied to seminary as a logical next step in the road to ministry. Seminary was an incredible and stressful experience for me. With moving to New Jersey, leaving behind my family, my girlfriend Dani Swanson, my friends, and my loving church, I felt tired and exhausted from class and distance between those important to me. My education at Princeton Theological Seminary was a continuation of my studies in college, but it was also a new beginning to my long-neglected spiritual formation. I found community outside of class through field education at Cedar Park Presbyterian Church. A challenging seminary experience was realizing how I ceased any spiritual formation after it was not being led for me while in church. I was religious, but I did not feel spiritual. I was not feeling connected to God. God was there, but I did not know where I was. I graduated from PTS with a plan to move back to Michigan and marry my Youth Group Sweetheart, Dani.

Marrying Dani has been one of the happiest and best decisions of my life. Our marriage was crucial to my survival and growth after seminary. Her love was a sustaining force for me when I did not know what to do next. The pathway to Ordination was Clinical Pastoral Education. I hesitated and floundered to start it. That time felt directionless for me. I moved from job to job until finally in the fall of 2018, I started as a CPE intern at Beaumont Health in Royal Oak, Michigan. As a chaplain, I wrestled with who I was and who I was called to be in God's ministry. In CPE, I reflected my relationship with God. From that CPE experience, I felt transformed once again by God's patience, love, and peace that I was called by a God who loved me abundantly. My transformation continued from an internship to a residency program to full-time position in chaplaincy. Everything I learned in my head finally connected with my heart. My spiritual life is awake and listening to God. I continue to learn more about God everyday through ministry, education, and experience. I feel, seek, and know God's presence in my life. I know I am called to be engaged in ministry for the sake of Jesus Christ and I let his love for me sustain that call. In Christ, I am beloved, desired, and wanted, just as all are.

Ordination is no longer a culmination of the CPM process or a product of going through CPE. Now, ordination is a piece of my journey with God and a journey that I am thankful to be on. As I continue striving to live with Christ in my heart and to share Christ with those around me, I am excited to have been called to Starr Presbyterian Church as a Temporary Supply Pastor. I hope to live into that call by the grace of God as that church embarks on its own transformation.

Dani and I welcomed our beautiful son Charlie in January 2020 and we are expecting another child in December 2021.

#### Statement of Faith

I believe and trust in the Holy God Almighty who was, is, and will be forever. I believe in a trinitarian God, a God of three distinct persons united and in relationship with one another. God is one. God is three. These three persons are God the Father, God the Son, and God the Holy Spirit.

I believe God the Father is the creator of all. God spoke into being all that is around us. God the Father is the parent to all creation and has ordained the laws of the universe for Humankind and Humankind was created in the image of God as male and female. Good's creation is sacred. The Creator, God the Father, resides in Heaven, a Holy realm of God's own. In our creation, we are good. Even as we are good, we sin. We sin as individuals, as institutions, and as a world. Sin influences us. Though we sin and fall short of our desired perfection, we are loved and forgiven. The Father sent to us the Son.

I believe God the Son is the redeemer of humanity. I believe God the Son came to us in the person of Jesus of Nazareth. This special and unique event in history is the incarnation of Jesus the Christ in which Son of God took on flesh and became human. God and human as one. Jesus taught and healed. He called twelve disciples to follow him. Jesus shared about the Kingdom of God. Jesus cast out demons. He rebuked those who were not living as God calls us to live. He challenged religious and political regimes that used violence and cruelty to attempt domination. Jesus was condemned to die on a cross. Jesus was innocent and blameless; he never sinned. Jesus suffered and died on the cross for our sins and to reveal God's unending love for all of creation. A God who suffers and dies for creation loves that creation so deeply. Jesus died on the cross, and then he was buried. After three days, he rose from the dead; it was a full resurrection of his body. I know God's forgiveness and love by the suffering and death of Jesus. God's love is over death. I know hope and I have life abundant by his resurrection. After Jesus rose from the dead, he met with his disciples. He gave them the gift of the Holy Spirit. He then departed earth and joined God the Father in Heaven.

I believe God the Holy Spirit is the sustainer of life. God the Father and God the Son gave us God the Holy Spirit. Though given by God the Father and God the Son, God the Holy Spirit is an equal in the relationship of the Trinity. Since the day of Pentecost, the Holy Spirit has been with us. It is a gift from God and being one with God since the beginning of time. Through the Spirit, God interacts with us to intercede on our behalf. Through the Spirit we receive callings. The Spirit of God is there when needed and wanted. The Holy Spirit shares God's love with all of creation. It is through the Holy Spirit that we meet Jesus. The Holy Spirit connects God's people together into the Body of Christ. It is in this way churches of God's people are formed to reflect the eternal Church of Jesus Christ. It is this Church that awaits the return of Jesus Christ to shepherd all of God's people at the end of time. As we wait, we continue to serve creation and call all people into communion with the Body of Christ.

The disciples of Jesus, by the Holy Spirit, were the first Church of Jesus Christ. Jesus is the head of that Church. It is universal and eternal. It is through the Holy Spirit that we minister two Holy Sacraments: Communion and Baptism. In Communion, we are united with Christ in Spirit, so that we may receive grace, know God's love, enjoy the presence of God, and be connected as a community of faith, hope, and love. Baptism is an act of God's grace in which we are claimed by the Holy Spirit and prepared to join the Body of Christ. There is only one baptism for the forgiveness of sins. The Sacraments are performed by those ordained by the Church and instructed in the faith. The Holy Spirit leads us in the sacraments; through the sacraments, we are strengthened and prepared to participate and witness the Mission of God. God's mission is to connect and bring all creation into union, love, and forgiveness.

# Presbytery of Detroit Interim Report by the Administrative Commission for Covenant Church Southfield (AC) July 13, 2021

# **Update:**

The AC's research into Covenant's roots from Southfield and Redford churches is leading the AC into an exploration of each church's history up through the selling of the Covenant church building. The AC also researched the history of the merged church. This research includes the relationship between each church and the Presbytery of Detroit.

The Covenant Session has cooperated with the requests of the AC. We have developed a relationship that is collegial and collaborative.

## **Actions taken by the AC:**

The AC has proposed a process to the Session of Covenant Church for development of a plan of ministry that will determine if Covenant Church is being called by God to merge, to nest, to yoke, or to dissolve. Our AC expects a unified outcome as a result of this process. The Covenant Session has unanimously accepted this process.

The AC has established a six-step timeline to complete this process is a timely and unifying manner. The process includes discernment of God's direction for Covenant Church and the establishment of actions to fulfill that discernment.

The AC has advocated for Covenant Church in its interactions with the Presbytery's Board of Trustees.
