# **Statement of Purpose**

(1st Presbyterian-Ypsilanti & 1st Presbyterian-Evanston)

Theological: God's love, covenant, justice

Ethical: Protection of all minors from all forms of abuse: sexual, physical, verbal, emotional

Legal: Congregational protection from legal action due to false accusations

# **Screening Process**

(All policies)

Be sure to check with your church's insurance company for their guidelines and requirements regarding safety policy elements and background check resources.

## <u>Volunteer</u>

Interview questions related to history with children

Background check for all volunteers (including current volunteers)

Signature on church safety policy stating volunteers have read and will follow policy

Six-month waiting period for volunteers who are new to the church

<u>Potential Employee</u> (Nursery Staff, Youth Leader, Christian Education Director, any staff in direct care of children):

Employment application with questions about history with children

National Criminal background check through:

Church insurance Screen Now program: low cost

Presbytery of Detroit resource: limited number

State of Michigan: free

Reference check: written and verbal

Signature on Church Safety Policy stating employees have read and accepted policy

Civil Law: Mandated reporter status for all ordained Ministers of Word and Sacrament Book of Order: Mandated reporter status for all ordained Elders and Deacons even though civil law does not require it

## Reporting process

Research your local child protective services and law enforcement agencies for phone numbers to distribute to volunteers, staff, elders and deacons. It is imperative that initial reporting is done immediately to civil authorities and not to church authorities.

# Definitions of prohibited behavior for volunteers and staff in regards to minors

(First Presbyterian Church of Evanston)

- Threatening or inflicting physical injury upon a child or youth other than by accidental means or in self defense.
- Committing any sexual offense against, or engaging in any sexual contact with a child or youth
- Making any kind of sexual to, making a request for sexual favors from, or engaging in other verbal, visual or physical conduct of a sexual nature with a child or youth.
- Entering, as an adult, into a dating relationship with a child or youth.

# Guidelines for physical contact with children & youth

(First Presbyterian Church of Evanston)

Touching may not be completely avoided, but staff and volunteers should be aware of how any contact looks and how the person being touched might interpret it. Side-by-side hugs should be used instead of full body contact. Youth leaders should not initiate or encourage back rubs, neck rubs, massages, kissing or similar contact.

# Supervision of Volunteers and Staff

Evaluate ratios of adult volunteers/staff required for each age group

Two adult minimum: Many smaller churches will need to think creatively about how to plan classroom spaces so that adult teachers may see each other through open doors or doors with windows when two adults cannot be provided for each classroom.

Review classroom visibility and open door policy Unannounced supervisory classroom visits

## **Reporting Procedures**

## Mandated Reporting of Offenses

In the state of Michigan, ministers of word and sacrament are mandated reporters. This means that civil law requires them to report suspected child abuse of any kind (physical, emotional, verbal, sexual) to civil authorities as soon as possible. In addition, the Book of Order requires all ordained elders and deacons to report child abuse to civil authorities even though they are not legally mandated reporters. Be sure to provide all mandated reporters with phone numbers and specific directions for reporting to local child protection agencies and police.

#### Policy Example:

(First Presbyterian Church of Evanston)

First Presbyterian Church directs all of its paid personnel and volunteers, even those who are not mandated reporters, to report to appropriate civil authorities their knowledge of the abuse of children or youth, if such knowledge is obtained while engaging in the ministries of First Presbyterian Church.

# Reporting to Church Authorities

## Policy Example:

(First Presbyterian Church of Evanston)

Beyond the legally mandated reporting situations, this policy requires that a report be made to church authorities in all cases when a violation of this policy is reasonably suspected. ......The suspected incident should not be discussed with anyone else. The parents of the alleged victims shall be notified in accordance with advice from Child Protective Services.

## Responsibilities of Church Counsel.

- Report the alleged incident of abuse to the proper authorities either Child Protective Services (helpful if that number for the appropriate county is listed here) or law enforcement.
- Send appropriate notice to any liability carrier for the Church and provide such carriers with information and such other cooperation as such carriers shall lawfully require
- If the alleged Incident of abuse involves a member of the clergy, report the alleged the Committee on Ministry of the Presbytery of Detroit

## Church Limitations Regarding Investigation

It is important to note that when reporting an abuse to authorities, one is not in the position to investigate or to be responsible for substantiating that abuse. It is the responsibility of that agency to conduct the investigation and to substantiate should the evidence prove abuse. The person reporting is simply responsible for presenting the facts as they know them.

## General Assembly

Excerpted from the 216<sup>th</sup> General Assembly Resolution on Allegations of Child Sexual Abuse Against Educators

#### Recommendations

3. Urge sessions and middle governing bodies to approve and implement strong sexual misconduct policies, procedures, and training programs for prevention of and protection from sexual misconduct.

### FINAL CLARIFICATION

Clergy Sexual Misconduct in <u>adult</u> relationships is reported to the Presbytery of Detroit Executive Presbyter, Stated Clerk or Committee on Ministry Chairperson.

Any Sexual Abuse toward <u>minors</u> (ages 0-18) is reported directly to civil authorities, either a Department of Protective Services or the police.
